## Terms of Use & Conditions

Payment is due the day before delivery. We accept payment by credit cards only. **Each dumpster includes a set number of days of use, a per day charge will be incurred if exceeded.** 60 days is the maximum rental period. If the 60-day time period happens, you will receive a call that we are picking up the dumpster. If you go over the tonnage included, a tonnage overage fee will be charged. If there is a balance due after the dumpster is picked up, your credit card will be charged, and you will be emailed a receipt. Any fees associated with debt collection or dumpster recovery will be charged to the customer.

*A return trip fee minimum of \$150 will be charged if an attempt to pick up or deliver a can is made and is canceled/inaccessible and/or unplaceable. Please note: DE Code #16-DE code-1709 does not allow for street placement of any dumpster. A return trip fee will apply if the can needs to be moved.*

Please note the following are not accepted at the landfill:

- Tires, propane tank, large drums, car batteries
  - A charge will incur for each tire in found in dumpster
- Hazardous material, paint (unless dried with kitty litter) or liquids
- TVs, appliances, computers, printers, electronics and other office equipment.

1. Please call if you have any doubt regarding the items being loaded and whether the landfill will accept those items. The additional charges incurred from unacceptable waste will be passed on to the customer.
2. Customers are responsible for items in the dumpster from the time of delivery to the time of removal.
3. Do not load materials above the "MAXIMUM LOADING HEIGHT", aka the sides of the dumpster. **Overloaded dumpsters will not be picked up until the overloaded debris is removed. A return trip fee minimum will be charged.**
4. Permits are the customer's responsibility and are usually required within city/town limits.
5. The price includes a set number of days to use our dumpsters. The day after delivery is considered your first day. Please call when you are done. **Removal is not automatic.** If the dumpster is not accessible and a return trip is necessary, will be charged.
6. Customers will be held responsible for any damage to our dumpster (i.e. large dents, holes, bending of steel structure, fire damage etc.) and will be charged for repair work.
7. Orange Cans, Inc. will make every effort to prevent damage to asphalt and concrete driveways. Orange Cans, Inc. however, is not responsible for property damage due to placement or pick up of our dumpster. If our trucks should get stuck where the homeowner/contractor has directed our driver to place the dumpster, any fee associated with towing our truck will be incurred by the homeowner/contractor. Any down time associated with becoming stuck will also be incurred by the homeowner/contractor.
